November 13, 2008: Bud of California/Dole Vegetables Defeats United Food and Commercial Workers.

In a stunning defeat, the UFCW lost in its long-sought bid to unionize all of Bud of California's vegetable cooling facilities on the West Coast. Barsamian & Moody represented the Company in this National Labor Relations Board election involving five different cooling facilities in two states over the last two and one-half months. The results of the tally of ballots: No Union-95 UFCW-58 Challenged-24. The number of challenged ballots is insufficient to affect the outcome of the election.
